

# Bicycle storage regulations

The following provisions apply to the use of the Flughafen Zürich AG bicycle storage zones:

## 1. General remarks

- 1.1 Flughafen Zürich AG is the operator of the bicycle storage zones.
- 1.2 The bicycle storage zones are generally accessible 24 hours a day, 365 days a year.
- 1.3 The instructions of Flughafen Zürich AG must be adhered to at all times.

## 2. Use of the bicycle storage zones

- 2.1 Entry into and use of bicycle storage zones is permitted only for the purpose of parking bicycles (including electric bicycles). Bicycles may only be parked in the bicycle storage zones.
- 2.2 Any bicycles left outside of the storage zones, bicycles parked for longer than 12 weeks, and bicycles impeding use of the storage zones, shall be removed without prior notice at the cost and risk of the owner. A fee of CHF 50 may be charged to cover the cost of removal and storage of bicycles. Bicycle locks must not be installed at the storage zones. Flughafen Zürich AG reserves the right to remove these and shall not be held liable for locks that are broken/damaged during removal.
- 2.3 Cleaning or repairing bicycles within the storage zones is prohibited.
- 2.4 Users are obliged to maintain order in the bicycle storage zones. Soiling and littering of any kind (e.g. dumping of refuse or littering) are prohibited.
- 2.5 The distribution of advertising material and flyers and/or the affixing thereof to parked bicycles is prohibited. No hawking is permitted. Persons not complying with these provisions will be invoiced for any resulting cleaning costs.
- 2.6 All traffic is subject to Swiss road traffic legislation. Persons failing to obey traffic signs will be reported to the police.
- 2.7 Unauthorised and unnecessary waiting in bicycle storage zones is prohibited. Staying overnight in the bicycle storage zones is not permitted.

## 3. Public and lockable bicycle storage zones

- 3.1 The public bicycle storage zones are available free of charge. Fees apply when vehicles are parked in the lockable storage facilities owned by Flughafen Zürich AG. These are based on the applicable rates set out in the staff parking conditions.
- 3.2 The lockable bicycle storage zones are accessed using a personal long-term parking card.

## 4. Liability

Persons using the bicycle storage zones do so at their own risk. Flughafen Zürich AG accepts no liability, in particular for damage to bicycles or bicycle fittings, or for theft of bicycles.

## 5. Damage to the property of Flughafen Zürich AG

- 5.1 Damage to facilities and equipment belonging to Flughafen Zürich AG may lead to criminal proceedings being initiated by Flughafen Zürich AG.

## 6. Breach of parking regulations

In the case of a breach of these parking regulations (e.g. non-payment of fees for lockable bicycle racks), Flughafen Zürich AG may issue a site ban to the person committing this breach or refuse that person access to Flughafen Zürich AG lockable bicycle storage zones. In the case of a violation of the statutory provisions (e.g. Swiss road traffic legislation or Swiss criminal law), Flughafen Zürich AG may initiate criminal proceedings.
